

Introduction

This document aims at offering to the Managing Authorities of the Interreg NEXT programmes a **compilation of procurement templates** which may be used by the public and private beneficiaries in the Partner Countries, as well as by the private beneficiaries in Member States not complying with the requirements to use national legislation, as stated in Article 58(1)(a) of the Interreg Regulation¹. Therefore, this compilation is not intended to be distributed directly to the beneficiaries but represents a support tool for the programme bodies, so that they can decide which templates recommend or require the beneficiaries to use.

The criteria for selecting or adapting templates are:

- Priority to the main templates supporting the compliance of the procedures set out in Annex II of the Financing Agreements between the European Commission and the partner countries.
- Lack of national templates in a significant number of countries.
- Availability of suitable templates either from PRAG or developed by programmes².

We excluded from the potential selection or adaptation:

- National templates available in most countries³.
- Technical documentation and related forms.
- Contractual documents.
- Letters for communication with bidders.

As a result from this work, we attach to this document <u>60 templates</u> covering all the procedures in Annex II. In the case of the excluded templates, we recommend either the use of national or own templates, for example on contracts, or the direct use of PRAG templates, such as the case for letters for communication with bidders. The summary of the proposal is:

Most selected templates developed by Hungary-Serbia and Romania-Serbia correspond to single tender procedure, for which there are no PRAG templates.

Even though the templates in this compilation are in English, we recommend the use of national language, except in the case of open tenders, to avoid language barriers with the local providers.

Complementing this document, TESIM is developing **factsheets on procurement** per each Partner Country, with a focus on the differences between the national legislation and the provisions in Annex II of the Financing Agreements, as well as the main provisions in this legislation which must be kept since not contradicting this Annex. The factsheets also include a list of recommended templates, including both the ones from this compilation and national ones. The factsheets also provide indications for private beneficiaries.

We hope that through these documents TESIM will efficiently support you in your quest for ensuring compliant procurement procedures by the project beneficiaries in Partner Countries.
